- › We are aware of the "Customs Value" leaflet on Form D.V.1. We undertake to observe all circumstances relating to the customs value mentioned herein and any subsequent changes and to notify our authorized representative in good time before submitting the customs value declaration. A relationship within the meaning of Article 127 UCC implementing act does / does not exist.
- › We hand over all documents necessary for customs clearance in individual cases to our authorized representative. This includes, in particular, import permits, licenses and valid proof of origin if we would like to make use of tariff preferences.
- › We will inform you of the customs tariff number and the description of the goods separately in good time. If no customs tariff number is available at the time of the import declaration, the authorized representative is entitled to determine independently based on the information available to him. We undertake to provide the authorized agent with existing binding tariff information or issued to us at a later point in time without being requested to do so, and to inform the authorized agent in good time if a binding customs tariff information becomes invalid.
- › Obligations according to foreign trade law are our responsibility. Existing bans and restrictions as well as other restrictions, in particular from customs law and international and / or political measures for international trade, are complied with.
- › We assume sole responsibility for the completeness, correctness and authenticity of all documents and information required for the execution of the orders. The authorized representative does not have to check or add to this.
- › The authorized representative has the right to issue sub-authorization.
- › We agree to the use and storage of our data for the purpose of the agreed contractual activities.
- › We are entitled to the full input tax deduction.
